



STORAGE RATE SCHEDULE AND AGREEMENT

WAREHOUSE HANDLING IN: \$ 3.75 per 100 lbs.

MINIMUM CHARGE PER OCCASION: \$ 65.00 minimum

STORAGE: for a minimum of a 30 day period, no prorating, beginning with the first day of receipt of goods: \$ 4.00 per 100 lbs.

MINIMUM CHARGE PER OCCASION: \$ 65.00 minimum

WAREHOUSE HANDLING OUT: \$ 3.75 per 100 lbs.

MINIMUM CHARGE PER OCCASION: \$ 65.00 minimum

This will serve as authorization for AVG Transportation Specialists, Inc. (hereinafter AVG) to store property with a third party for the below mentioned company. Storage charges are due and payable upon receipt of invoice. Interest will accrue at the rate of 18% per annum on any balance outstanding more than fifteen (15) days from the date of billing. All outstanding charges with AVG, including finance charges, must be PAID IN FULL prior to the property being released or prior to the delivery date, whichever is sooner. If payment is not received within thirty (30) days from the date of billing, AVG may destroy or otherwise dispose of the stored property, after giving the company named below ten (10) days notice by regular, first class mail, postage prepaid, addressed to the address noted below. The cost of disposing of the property will be reimbursed to AVG by the below mentioned company within ten (10) days of billing. In the event that the disposition of the property results in any payment to AVG, AVG will apply that payment to the outstanding balance and costs of disposition and the below mentioned company will remain liable for the remaining balance. In the event that the property is disposed of or destroyed pursuant to this agreement, the below mentioned company acknowledges and agrees that AVG / third party will not be held responsible for the value of the destroyed property or for any damages arising from the disposition or destruction of the property or AVG's failure to deliver the goods in storage. In the event that AVG shall hire an attorney to enforce any provisions of this Agreement, the below mentioned company agrees to pay all reasonable attorney fees and costs incurred by AVG. In the event that it becomes necessary to file a lawsuit to enforce any of the provisions of this Agreement, the below mentioned company agrees to submit itself and this matter to the jurisdiction of the King County Superior Court in the state of Washington for final determination.
